## 7. Allocation of Marks and any Additional Requirements

7.1. Module Marking (total 50\%)

Each module will be marked according to the common marking scheme and scaled to $5 \%$ for each module. If more than 9 modules have been completed, the supernumerary modules (core or elective) with the lowest marks shall be discounted, providing at least 4 core modules remain.
7.2. Research Project Marking (total 50\%) Written Research Project (40\%)

Where this is an examination this would be at the next available sitting. <br> A student who has not achieved more that $40 \%$ in a module will be able to attempt to pass a different module. The number of modules that can be attempted and failed is limited to 5. |
